The largest program services include research grants to foreign and domestic organizations advancing Nemaline Myopathy science. Domestically, grants supported the development of gene therapy for ACTA1-based Nemaline Myopathy; gene replacement and drug screening studies for KLHL40-, KLHL41-related forms; creation of patient-derived 3D muscle models to test potential treatments; maintenance of a national biobank to advance research and clinical trial readiness; and development of soft robotic garments to assist lower-limb movement and improve mobility for children with NM. Internationally, grants supported research to test therapies for KBTBD13-related Nemaline Myopathy (NEM6) using a mouse model to determine treatment timing and efficacy in preventing or reversing disease progression.
